Land Acquisition & Preservation - In 2015 The Highland's Nature Sanctuary, Inc. (HNS) (dba the Arc of Appalachia) expanded its preserve holdings by 303 acres. All of these new land acquisitions were funded by a combination of private donations, Ohio Public Works Clean Ohio grants, and two grants from the Ohio Department of Natural Resources. Through the agency's efforts over its twenty year history, 92 separate land projects totaling 4,638 acres of wild lands have been preserved including 166 acres of conservation easements. Since 2008, HNS has also managed two sites on behalf of The Ohio History Connection: Fort Hill and Serpent Mound, both notable prehistoric Native American earthworks and natural areas. Thus during 2015 HNS managed, monitored and preserved a total of 5,703 acres. Thirty two miles of hiking trails were stewarded. A major priority during 2015 was the removal of invasive plants. Efforts were concentrated at the Highlands Nature Sanctuary, Ohio River Bluffs, Chalet Nivale and the Junction Earthworks preserves. In 2015 a new and highly successful 16 week program was initiated in partnership with the Ohio Department of Rehabilitation and Correction and Alvis Halfway House located in Chillicothe, Ohio. Prisoners approaching re-entry into society were taught by an HNS employed supervisor to remove invasive plants from HNS preserves thus gaining new

Education -The Highlands Nature Sanctuary, Inc. (HNS) (dba the Arc of Appalachia) is committed to teaching citizens about the value of their natural landscapes through workshops, field trips and guest lectures. A total of 3,689 individuals participated in 69 total events during 2015. HNS continued management of two Ohio History Connection sites, Serpent Mound and Fort Hill. Each site included a Museum. During 2015, over 28,521 daily visits were officially recorded at the Serpent Mound Museum, with an estimated total attendance of 33,521. A visitor count of 14,870 was recorded at the Fort Hill site. At the HNS headquarters, a total of 4,695 individuals visited the Appalachian Forest Museum. HNS's five historic lodges hosted 1,739 guests who participated in educational programs, trail hiking and other outdoor experiences for a total of 518 nights of occupancy. HNS also hosted it first Artist in Residence program. A total of five artists participated in the three week program. The artists hosted educational programs and workshops for children and adults and sponsored a public gallery showing at the end of the program. An on-line book of their work has been prepared and will be made available to the public at a price that just covers the cost of production.
