Land Acquisition & Preservation - In 2017 The Highland's Nature Sanctuary, Inc. (HNS) (dba the Arc of Appalachia) expanded its preserve holdings by 265 acres thus bringing the total natural areas purchased since the organization inception in 1995 to 5,993 acres. Of the 5,993 acres, HNS managed/monitored 5,728 acres. The remaining acres were deeded over as preserves to other nonprofits or government groups. The total acreage represents 106 separate land acquisitions over 22 years in 18 preserve regions. Three new properties, totaling 85 acres, were funded by a combination of private donations and Ohio Public Works' Clean Ohio grants. In addition to these purchases, two properties were donated to HNS: a five-acre parcel near Fort Hill and 175 acres by Dayton Power & Light to the Ohio River Bluffs Preserve. No new conservation easements were added in 2017. However, HNS continued to monitor three conservation easements totaling 296 acres. Since 2008, HNS has managed two sites, Fort Hill and Serpent Mound, on behalf of The Ohio History Connection (OHC). Both are notable prehistoric Native American earthworks and natural areas. During 2017, forty-one miles of hiking trails were stewarded for public enjoyment. One new public trail system was added in 2017 at the Gladys Riley Golden Star Lily Preserve. The major land stewardship priority in 2017 continued to be the

Education - The Highlands Nature Sanctuary, Inc. (HNS) (dba the Arc of Appalachia) is committed to teaching citizens about the value of Ohio's natural landscapes through workshops, field trips and guest lectures. More than 4,701 individuals visited the Appalachian Forest Museum. HNS's five historic lodges hosted 1,762 guests who participated in educational programs, trail hiking and other outdoor experiences. Over 5,958 individuals participated in more than 54 educational programs during 2017 including the Wildflower Pilgrimage, two Women's Retreats, the third year of the Artists in Residence Program, and additional workshops and hikes. HNS continued management of two Ohio History Connection sites, Serpent Mound and Fort Hill. During 2017, Serpent Mound recorded nearly 24,291 visitors to its Museum and earthworks. Car counter attendance at Fort Hill recorded 13,074 visits. Total attendance to all HNS preserves, events and functions in 2017 was 64,848 people.
