Land Acquisition & Preservation - In 2018 The Highlands Nature Sanctuary, Inc. (HNS) (dba the Arc of Appalachia) expanded its preserve holdings by 731 acres thus bringing the total natural project areas purchased since the organization's inception in 1995 to 6,714 acres, 6,527 acres of which are actively monitored and managed by HNS. Total acquisitions represent 113 separate land acquisitions over 23 years in 19 preserve regions. New acquisitions included an expansion of the Rock Run Preserve, the Ohio Hanging Rock Preserve and the Highlands Nature Sanctuary Preserve. Two major donations were accepted. Mark Baker donated his home, barn and cabin on 15 acres to the Highlands Nature Sanctuary with retained life estate. Marje Obrist donated 71 acres of land immediately adjacent to the Samson Woods Preserve, bringing the total acreage of this preserve to 146. HNS continued to monitor two conservation easements totaling 286 acres. During 2018, forty-one miles of hiking trails were stewarded for public enjoyment. A new trail system was established at Steel Earthworks, connecting Steel Earthworks with Junction Earthworks, both owned by HNS. A major trail revision and renovation project was continued at the Highlands Nature Sanctuary to continue opening more trails to the general public and increase safety: Cedar Run Trail was rerouted to a safer trail head, and new concrete steps

Education - The Highlands Nature Sanctuary, Inc. (HNS) (dba the Arc of Appalachia) is committed to teaching citizens about the value of Ohio's natural landscapes through workshops, field trips and guest lectures. 5,612 people visited the Appalachian Forest Museum, with another estimated 2500 people accessing the trails directly at trailheads, together representing nearly a 20% increase. Highlands Nature Sanctuary attracted 2448 guests who stayed in overnight facilities, providing easy access to trail hiking and other outdoor experiences. A major renovation occurred at the Appalachian Forest Museum in 2018 with the major assistance of funding through Ohio Facility Construction Commission Grant. Improvements included the installation of two new forest murals in the Appalachian Forest Museum, new iron fencing for security and aesthetics, new parking flow, narrowing the main entrance to one-way, and a new stone terrace in front of the Cave House (Main Office). During 2018 a total of 4,657 individuals participated in educational programs, including the annual Wildflower Pilgrimage, two Women's Retreats, Appalachian Forest School intensive nature courses, the fourth year of the Artists in Residence Program, home school education days and free guided hikes. HNS continued management of two Ohio History Connection sites: Serpent Mound and Fort Hill. Car counter attendance at Fort Hill
